1. Application (the first file with the name “Application”) addressed to the conference organizing committee indicating:

- 1.1. Surnames, name, patronymic (in full); academic degree and title; work places;
- 1.2. Contact phones, fax, postal (with zip code) address (to send book collection) and the author's email address;
- 1.3. Conferences and sections;
- 1.4. Article titles;
- 1.5. The author's intent to purchase a compilation (book) - “intends”, “no”.
- 1.6. Scanned copy of payment receipt.

2. Article (second file with the title “Article”), arranged according to the requirements:

An article is attached to the application. The order of the article see below:

- Name of the author, academic degree, academic title, place of work, e-mail address;

- Through the string the title of the article in the center in CAPITAL LETTERS (in boldface);
 - Through the string - annotation (from 80 to 100 words) - in three languages (Kazakh, Russian and English);
 - Through the string - keywords (no more than 10-12 words or phrases);
 - Through the string - text;
 - Through the string - references (font - italics);
 - The volume of the article - up to 8 pages (minimum volume - 5 pages, in exceptional cases - 10-12 pages);
 - Text should be typed in Word 97-2003;
 - Font - Times New Roman;
 - Size of type - 12;
 - The interval is 1.0;
 - Page parameters: top and bottom - 20 mm, left - 30 mm, right - 15 mm.

Deadline for submission of applications and articles: until March 1, 2019 inclusive.

Sending compilations: until April 1, 2019.
