### **4. A brief analysis of the dissertation work on the fact that the dissertation council for the reporting year has divided the following year:**

#### **1) the analysis of the titles of the dissertation.**

**4.1.1/1** Kurmambayeva Zhuldyz Baltabekovna. The theme of the dissertation: ‘Linguocultural basis of the numerals in Kazakh language’.

*The relevance of the dissertation.* One of the channels of multidisciplinary theoretical research which characterizes the directions of modern Kazakh linguistics, opens the way to the study of language in the linguo-cultural aspect, the possibility of language in the representation of cultural categories. In this regard, one of the priorities of modern Kazakh linguistics is study of the continuity of the linguistic and cultural content of numerals in everyday life with the world around them, the nature of the ethnos, the worldview of the nation, human factors. Therefore, the doctoral student’s anthropocentric study of numerals in the linguistic and cultural aspects of lexical materials and concepts, in which the numerals are based, shows the relevance of the title and the need for scientific demand.

**4.1.2** *The relationship between the directions of development of science and the title of the dissertation formed under the control of the higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in*

accordance paragraph 3 of Article 18 of the Law "On Science" and (or) state programs.

The theme and content of the dissertation are confirmed by the basic scientific apparatus, theoretical considerations and summaries made by specific analysis in the process of deciphering the cultural code of numerical concepts. The structure of the research work compliance with technical requirements, content, language use (scientific style), the degree of use of the necessary scientific literature, the cope od work fully meets the requirements for doctoral dissertations (PhD). The results of the dissertation and the proposed scientific conclusions are based on the works of well-known scientists on the subject, scientific theories of language, and the cultural semantics of scientific numerical concepts are confirmed by linguistic data. The linguistic content of the transmission of numerical concepts through the background of human consciousness is analyzed in detail, and linguistic analysis in terms of the conceptual field is highly correlated with the development of modern linguistics and dissertation theme.

**4.1.1/2 Yersultanova Gaukhar Tileukabulovna.** The theme of the dissertation: «The language personality in the journalistic discourse» (on the basis of modern Kazakh press).

*The relevance of the dissertation theme.* Modern linguistics research examines a variety of issues in society and everyday life in the study of language in connection with the process of anthropology. Particular attention is paid to the issue of linguistic discourse, and the ability to demonstrate the linguistic potential of the linguist involved in the discourse opens the way for the development of new linguistic concepts. In this regard, one of the main problems of modern Kazakh linguistics is the study of the continuity of the pragmatic content of discourse in the journalistic space, the driving force of public life, the social environment, ethic culture, political phenomena, national ideology, human factors. Therefore, the research work of the doctoral student on the basis of media materials and content based on linguo-pragmatic issues of journalistic discourse, consideration of the discursive use of media materials in ethic culture in the linguo-cognitive and linguo-pragmatic aspects shows the relevance of the theme and the need for scientific demand today.

**4.1.2 The relationship between the directions of development of science and the title of the dissertation<sup>6</sup> formed under the control of the higher Scientific and Technical Commission under the Government of the Republic of Kazakhstan in**

The dissertation is based on the linguistic analysis of the conceptual field in terms, reflecting the nature, identity, linguistic structure of the relationship between the individual and society in the journalistic discourse. The doctoral student was able to rationally use discourse and linguo-cognitive analysis to reflect the cultural and cognitive nature of the language personality in journalistic discourse. The analysis of specific journalistic materials with references used in the work is highly correlated with the development of modern linguistics and the title of the dissertation.

*The relevance of the dissertation theme.* In modern linguistics, the study of linguistic phenomena and facts not in terms of traditional grammar, but in the context of the anthropocentric paradigm is a well-established scientific direction these days. To demonstrate the power and depth of the roots of Kazakh language can be demonstrated through linguistic analysis of mythological works. In this regard, the relevance of the work shows the importance of the dissertation theme and the fact that it is a problem of today's demand and scientific needs. The purpose of this dissertation is to cover the content of examples form Kazakh and English fairy tales, as to make a semantic analysis of them. In addition, the study of Kazakh-English fairy tales through a comparative study of Kazakh-English fairy tales shows the importance of the title of the dissertation.
