A scientific and practical model of dual-oriented training of special teachers has been developed, which is a holistic process, describing the goals, methodological foundations, principles, motivational-personal, operational-activity and content components, criteria, indicators and training results.

- 4. A multicomponent program for organizing an educational research laboratory and a variety of practices as forms of dual-oriented training for future special teachers have been developed.

Description of the main results of the study:

- 1) The essential characteristics of the expanded content of the concept "social activity of deaf primary schoolchildren" are given in the context of the significance of subject-related practical activities;
- 2) A low level of development of the content components of social activity (duty, initiative, responsibility) of deaf primary schoolchildren was revealed; the pedagogical conditions and features of the development of social activity of deaf students in grades 1-2 in the process of subject-based practical training are determined;
- 3) A scientific and practical model for the development of social activity of deaf students in grades 1-2 in the conditions of subject-based practical training has been developed, the effectiveness of which has been tested by experimental work;
- 4) A verified variable program has been developed for the development of social activity of deaf primary schoolchildren based on subject-based practical activities.
