### ANNOTATION

**Research topic:** "Development of the undergraduates' professional personal qualities in the conditions of multilingual education".

**The purpose of the study** is theoretical substantiation of the development of undergraduates' professional personal qualities in the conditions of multilingual education, methodology development and conducting a practical experiment on its effectiveness.

### **Research objectives:**

- determination of theoretical foundations for the development of undergraduates' professional and personal qualities in the context of multilingual education;

- to determine the essence and content of the development of undergraduates' professional personal qualities in the context of multilingual education;

- development of a structural and functional model for the development of undergraduates' professional personal qualities in the context of multilingual education;

- experimental testing of the effectiveness and development of a methodology for developing undergraduates' professional personal qualities in the context of multilingual education.

**Research methods:** *theoretical methods*: theoretical analysis of philosophical, psychological and pedagogical literature on the problem of research; familiarization with the normative legal documents of the education sector of the Republic of Kazakhstan, concepts of students' personal development; analysis of best practices; comparative analysis of the results activities; *practical methods*: conducting surveys, testing, using diagnostic methods, methods and methods of statistical processing.

The main provisions (proven scientific hypotheses and other conclusions that are new knowledge) submitted for defense:

- "Multilingual education" is a tool for the development of professional and personal qualities of the individual in the integration of trilingual interethnic material and spiritual cultures". "A multilingual person is a person who has developed professional and personal qualities in the process of mastering three languages in the integration of interethnic material and spiritual cultures".

*-Professional and personal qualities of undergraduates* are an integrated set of special knowledge, skills and personal qualities with qualitative indicators necessary for the successful implementation of their professional activities in the future". In the context of multilingual education, we define the professional and personal qualities of undergraduates in two groups: **professional** (*cognitive knowledge, professional thinking, academic skills*); **personal** (*empathy, tolerance,* sense of patriotism). Defined professional and personal qualities are reflected in the scheme" professional activity-communication – interpersonal interaction".

-Structural and functional model of the development of undergraduates' professional personal qualities in the context of multilingual education unity of conceptual, *technological, effective parts, psychological and pedagogical conditions* for its effective implementation (consideration of multilingual education from the point of view of a tool

for personal development; mastering in the integration of interethnic cultures; implementation of the development of professional and personal qualities in the scheme "activity-communication-interpersonal interaction"), the criterion-evaluation component (emotional-volitional, cognitive-creative, communicative-evaluative) and its corresponding criteria and indicators.

-Creation of pedagogical opportunities for the development of undergraduates' professional and personal qualities in the context of multilingual education and its theoretical and practical justification; use of interactive methods in the process of training teachers-psychologists"; "*psychological and pedagogical bases of training for managerial activities in educational organizations*", "*innovative activities of a manager, "pedagogical criteria in the Republic of Kazakhstan and the CIS countries*" "*multilingual education-a tool for the development of professional and personal qualities of a master's student*"; In the implementation of the action plan" Y research discussion club" (Young Researcher Discussion Club); in the implementation of the International Project "International of education", it will be effective in the implementation of offline combined learning using innovative methods and techniques.

## Main results of the study:

-the essence and content of the development of undergraduates' professional and personal qualities in the context of multilingual education are determined; the psychological aspects of "multilingual education" are justified from the point of view of the tool for the development of undergraduates' professional and personal qualities are determined.

-a structural and functional model of effective implementation of the development of undergraduates' professional and personal qualities in the context of multilingual education has been developed, which includes the content, psychological and pedagogical conditions, criteria and indicators in accordance with the evaluation components;

-a methodology for developing undergraduates' professional personal qualities in the context of multilingual education has been developed, and its effectiveness has been experimentally tested and recommendations have been made.

# Justification of the novelty and significance of the results obtained and their compliance with the directions of scientific development or government programs:

The novelty of the first result corresponds to the innovative directions of modern science and education, the state language policy and state programs of the Republic of Kazakhstan in the field of Education. The significance of the result is determined by the compliance of the national project "Bilimdi Ult", the national plan "100 concrete steps", the state program "Rukhani Zhangyru: the course to the future", the professional standard of a teacher in the framework of the modernization of Education. It is also characterized by the novelty of the author's interpretation of the concepts" multilingual education"," multilingual personality"," professional personal qualities of undergraduates","

professional and personal qualities of undergraduates in the context of multilingual education".

*The second result* of the analysis of the group "types of professional qualities", "types of personal qualities" in the works of scientists is determined by a reasoned description of its content, dividing the undergraduates' professional and personal qualities into two groups: professional (cognitive knowledge, professional thinking, academic skills); personal (empathy, tolerance, nationalism) in the context of multilingual education.

*The third result-*" knowledge and professional skills – the main guidelines of the modern education system, training and retraining of personnel In the strategy "Kazakhstan-2050" will be aimed at the development of professional and personal qualities of future scientific and pedagogical personnel. In accordance with this, it is characterized by the development of a structural and functional model that includes the unity of conceptual, technological, effective parts, criterion-evaluation component (emotional-volitional, cognitive-creative, communicative-evaluative) and criteria, indicators, and the definition of psychological and pedagogical conditions necessary for its effective implementation.

*The novelty and significance of the fourth result* will be determined by the development of a methodology that includes forms, methods and tools for developing of the undergraduates' professional personal qualities in the context of multilingual education.
